**Sub:** St.Mary's Hr.Sec.School, Pothakalanvilai, Thoothukudi District - Civil appeals 1868-69/2014 disposed on 12.03.2018 - Cancellation of conditional approval given to the appointment of Mr.Jeyaseelan Antony Raj in my place w.e.f 24.08.1998 requested - Immediate stoppage of salary to him requested - Recovery of salary and other benefits given to him requested - Cancellation of Retirement benefits sanctioned to him requested - Reg

In St.Mary's Hr.Sec.School, Pothakalanvilai, Thoothukudi District, Mr. Jeyaseelan Antony Raj was promoted and appointed in my P.G.History Post with effect from 24.08.1998 immediately after dismissing me from service. I challenged the dismissal order in WP.No.14632/98. Since I believed that I would win the case, I filed WMP.No.22211/98 in WP.No.14632/98 and prayed restraining approval of his promotion and appointment pending disposal of the above Writ Petition. The Hon'ble Court was pleased to dispose my petition passing the following order. "Any appointment will be subject to the result of the writ petition". Thus the Hon'ble court safeguarded my interest.

You approved his appointment as follows w.e.f 24.08.1998 after obtaining an undertaking from the correspondent to the effect that the management would carry out the Direction of High Court of Madras to be passed in W.P.No.14632/98.


Further, through your proceedings Na.Ka.No.2082/B4/13 dated 04.07.2013 I understood that you had obtained opinion from the Government Pleader before approving the appointment of Mr. Jeyaseelan Antony Raj in my place.

The school management changed the punishment of dismissal as removal and then as compulsory retirement. All these punishments were set aside by the Hon'ble High Court in different cases as mentioned in my previous representations. Further, the School management preferred appeal before the Hon'ble Supreme Court where it was admitted as civil appeals 1868-69/2014 on 20.01.2014. The Hon'ble Supreme Court was pleased to dispose the above civil appeals on 12.03.2018 allowing pension to me from the date of Superannuation with 15% of backwages.

Consequent to the order passed by the Hon'ble Supreme Court of India in the above civil appeals, the conditional approval given by you to the appointment of Mr.Jeyaseelan Antony Raj in Na.Ka.No.10326/B3/98 dated 18.12.98 is automatically liable to be cancelled with immediate effect. Further, the grant released to him from the government exchequer right from 24.08.1998 should be recovered from the school management as per the undertaking given by the Correspondent and thus you should save public money that was given wrongly to the above teacher by the wrong claim of the school management.

Therefore, under these circumstances, I request you to stop all government grants being released to Mr.Jeyaseelan Antony Raj with immediate effect and cancel all the pensionery benefits sanctioned to him in your proceedings R.C.No.4103/B4/17 dated 04.08.2017. I request you to recover the salary and all other kinds of government grants given to Mr.Jeyaseelan Antony Raj right from 24.08.1998 to date with immediate effect from the school management in accordance with law. Thanking you.
