In the capacity of Secretary of AVE MARIA association I filed W.P.No.8491/2009 before the Hon'ble High Court of Madras challenging the transfer power given by the government to the school management, R.C.Schools, Thoothukudi. You held the office of the Superintendent of R.C.Schools, Thoothukudi from 01.05.2010 to 14.05.2012. In the above writ petition you were the 8th respondent and the Manager of R.C.Schools, Thoothukudi, is the 7th respondent. In the capacity of the above office you filed the counter affidavit first cited above. In the counter affidavit in para 7 you submitted that cadre-wise common seniority was maintained for all the employees under your management with the intention of defeating my petition. Since your statement was not true, I requested the copy of common seniority list for the years 1990-91 to 2010-2011 in full shape through the second letter cited above under RTI Act 2005.

The following is the information requested from you under item 2 of my RTI petition dated 15.03.2011.

In the counter affidavit submitted by Rev.Fr.M.G.Victor for the W.P.No.8491/2009 it is mentioned in paragraph 7 that a common seniority list is maintained at the Diocesan level according to the cadre from the date of appointments. Further, in the same paragraph it is mentioned that the common seniority list is being updated every year. Please send me the
