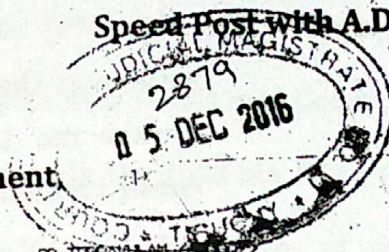

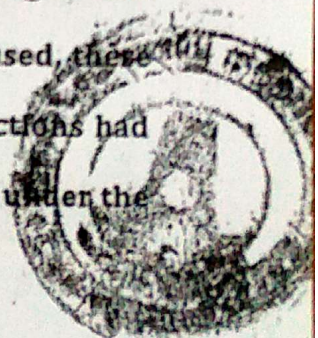


same way they entering into criminal conspiracy to cheat and harass me in a Covetous manner they had grabbed my research land - Requesting CBI Probe regarding.

- Ref: 1. My Petitions dated 13.03.2012 and 29.07.2006 with the enclosed documents revealed Bishops and Clergy's about 78 persons misappropriated many crores of funds and other grave allegations.

3. Notice for agitation, rally and procession against the Government of India of the "The National Education Policy, 2016" Conducted by the Arch-Bishops, Bishops and clergys of catholic Christian Mission of Tamil Nadu.

Rev. Susal Alangaram and his Ilanthallur Trust joining hands with Trichy Diocese Bishop Antony Devotta had grabbed my research land and cheated me, further their response was threatening of my life. In this regard the CCB - Police, Trichy filed the FIR.No.20/2007. But the CCB - Police, Trichy had not acted on their FIR. I aggrieved over the CCB - Police action, I filed a petition at the Hon'ble the Madurai Bench of Madras High Court CrI.OP (MD) No.10651 of 2011. Hence, matter had transferred to the CB-CID Investigation on dated 17.12.2014.

Even the CB-CID FIR.No.1/2015 Contained grave charges and allegations against the Bishops and the Clergys and other accused, these charges have been omitted by the CB-CID and appropriate Sections had been invoked. The CB-CID did not invoked proper sections under the

But they are saying we are pleading for these suppressed class of christians people. But these suppressed class christians having unflinching and unalloyed faith coupled with love of GOD, live with eyeful of tears without getting any concession whatsoever. This will apply only to Bishops, Clergys and their families and persons holding posts in higher ups in the catholic institution .

The Bishops and Clergys of Catholic missionaries claim the right to manage a Trust, Society and Minority institutions, But they cannot eligible to claim a right to Criminally mismanage the same. So, they cannot right and eligible to claim under Article of 30(1) of the constitutional rights.

Whereas, Dr. A. Yesudoss preferred a 1st appeal dated 05.11.2016 against this office's reply 21.10.2016 towards his RTI application registration No. MHOME/R/2016/02582 dated 27.09.2016 under RTI Act, 2005 pointing out that the CPIO of this office (appearing at SN. 4 of 1st appeal) has not provided any information, document copies and file notings about of the Catholic Bishops and Clergies of their funds, prior permission list, licence to receive funds from abroad, renewal of the foreign funding licence, FCRA Act violations, Non-declaration of foreign donations, diversion of foreign funds to other unlawful users and whether the Ministry sent any questionnaire and the Catholic Bishops, Clergies and Society members, trustees replying to the Ministry's questionnaire.

2. Whereas, it is noticed that he, vide his RTI application dated 14.09.2016, forwarded with application dated 27.09.2016, had asked "Please provide me the information, details and documents copies with file noting of the action taken on those" as referred at point No. 1 & 2 of RTI application dated 14.09.2016.

3. Whereas, the CPIO had rightly replied to his RTI application. Since, the action on his grievances registered on the portal of PMO vide registration number PMOPG/D/2016/0227135 dated 12.08.2016 is still under process in consultation with the field agencies, this office is unable to provide the information/documents sought.

4. In view of the above, the 1st appeal dated 05.11.2016 made by Dr. A. Yesudoss against reply dated 21.10.2016 to his RTI application dated 14.09.2016 (& 27.09.2016) is hereby disposed off.

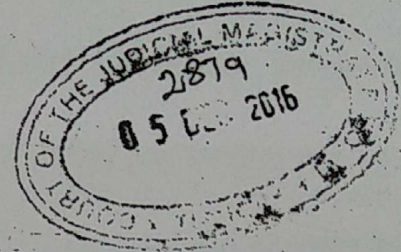
