Respected Sirs,

The Tuticorin Diocesan Association, (Reg.No.S1/37-38 dated 14.04.1937), located at 82, G.C.Road, Thoothukudi - 628 001, is an NGO. As per the list published by NGO on 21.03.2016 it runs 130 Primary Schools, 60 Middle Schools, 18 High Schools 20 Higher Secondary Schools, 2 Matriculation Schools, 2 Teacher Training Institutes and 3 Industrial Schools. According to this list 98 Schools come under the jurisdiction of No.1 of you and 130 schools come under the jurisdiction of No.2 of you. This NGO is the Educational Agency of the above schools.

The above 228 schools obtained recognition separately for each school. They enjoy recognition and grant separately. As per the Full Bench order passed on 30.04.1998 by the Hon'ble Madras High Court in W.A.Nos.275 and 1037 of 1989 and W.P.Nos.7193 and 7235 of 1986 each school is separate unit. Recognition and affiliation are given to the school, not to the management. The Hon'ble Court finally held that there is no minority corporate management recognized by the authorities.

Rev.Fr. Theophilus, the Secretary of this NGO, appointed one Bishop Yvon Ambroise as the Manager of R.C.Schools in his Proceedings No.B2/1-6 dated 18.05.2005. The official copy of this appointment order was given to me by the District Educational Officer, Thoothukudi, in the presence of the Information Commission on 13.07.2016. A bare reading of this appointment order would show that this is an illegal order. I

challenged validity of this order in W.P(MD)No.1843/2017 which is pending before the Hon'ble Madurai Bench of Madras High Court. However, the Bishop Yvon Ambroise was issuing various orders such as appointments, transfers, promotions, suspensions, dismissals, removals, compulsory-retirements and so on using the designation of Manager, R.C.Schools, Tuticorin Diocese. All the orders signed using this designation have been treated as valid and approved by No.1&2 of you and your subordinate officers.

No.1 of you in your Proceedings O.Mu.No.101077/G2/E3/2007 dated 28.01.2008 has clearly informed to Mr.Robert Fernando under RTI Act 2005 that the approval of the Government for the seniority list of the teachers of the R.C.Schools in the Diocese of Thoothukudi is not in force so far. Thus it is clear that the Educational Agency of the above schools has never maintained common seniority list.

Fr.M.G.Victor, the Superintendent of R.C.Schools, Tuticorin Diocese, in his letter No.2011/167 dated 04.05.2011 has clearly confirmed that the school management is not maintaining any approved seniority list.

Another important issue is that Bishop Yvon Ambroise manufactured minority declarations for the above schools. His designation in the declaration of minority right given for St.Mary's Hr.Sec.School, Pothakalanvilai, Thoothukudi District and Manal Matha Higher Secondary School, Sokkankudieruppu, Thoothukudi District, is Manager, R.C.Schools, Tuticorin Diocese. In these declarations he declares that the Educational Agency of these schools is The Roman Catholic Diocese of Tuticorin.

As such, I understand that he has changed his designation as "Corporate Manager, R.C.Schools, Tuticorin Diocesan Association, Tuticorin without any permission from the government. He has used this new designation in his proceedings PRO/2017-2018/08 dated 14.09.2017 to give promotion to a junior teacher namely Mrs.S.Jeya Ugin Mary in Manal Matha Higher Secondary School, Sokkankudieruppu, Thoothukudi District. Further, Bishop Yvon Ambroise in his proceedings 2017/11 dated 23.01.2017 extended suspension of Mr.Jeyasingh Cruz Angelus of the same school by the designation of Manager of R.C.Schools, Tuticorin Diocese.


I state that his appointment as Manager of R.C.Schools, Tuticorin Diocese, by the proceedings No.B2/1-6 dated 18.05.2005 has already

been challenged by me in W.P(MD)No.1843/2017. This case is pending before the Hon'ble Madurai Bench of Madras High Court. Both of you are respondents in the above case. While the Writ Petition is pending before the Hon'ble Court he has willfully and purposely changed his designation as "Corporate Manager, R.C.Schools, Tuticorin Diocesan Association, Tuticorin. This change will affect my case and divert justice.

Hence, under these circumstances, I request both of you to take appropriate action against Bishop Yvon Ambroise and the Educational Agency "The Tuticorin Diocesan Association" for changing the designation without any authority & permission in violation of the order passed by the Hon'ble Full Bench of Madras High Court on 30.04.1998 and direct the Educational Agency not to make any change in the designation of Manager in respect of school administration of the Educational agency pending disposal of the W.P(MD)No.1843/2017.
