Notice

All of you are aware that I was dismissed from service on 24.08.1998 and Mr. Jeyaseelan Antony Raj was directly promoted from Secondary Grade post to my P.G.History Post with effect from 24.08.1998 in St.Mary's Hr.Sec.School, Pothakalanvilai, Thoothukudi District. I challenged the dismissal order in WP.No.14632/98 and I filed WMP.No.22211/98 in WP.No.14632/98 and prayed restraining approval of Mr.Jeyaseelan Antony Raj's promotion and appointment pending disposal of the Writ Petition. The Hon'ble Court was pleased to dispose WMP.No.22211/98 on 22.09.1998 by passing the following order. "Any appointment will be subject to the result of the writ petition". Thus the Hon'ble court safeguarded my interest.

The office of No.1 of you granted conditional approval to his appointment after obtaining clear undertaking from the correspondent to the effect that the management would carry out the Direction of High Court of Madras to be passed in W.P.No.14632/98. The following approval details have been clearly recorded in his Service Register and appointment order.

The office of No.1 of you has obtained legal opinion from the Government pleader before approving his appointment. This is clearly expressed in the proceedings Na.Ka.No.2082/B4/13 dated 04.07.2013.

By suppressing the conditional approval given to Mr. Jeyaseelan Antony Raj in Na.Ka.No.10326/B3/98 dated 18.12.98, No.2 to No.5 of you got application for claiming retirement benefits from Mr.Jeyaseelan Anthony Raj and forwarded it to the office of No.1 of you suppressing the facts in a hurry on 22.07.2017 which was processed on 27.07.2017 and pension and other retirement benefits were sanctioned by No.1 of you in proceedings R.C.No.4103/B4/17 dated 04.08.2017. Only the signature of Mrs. Kokila, DEO are available in the proceedings. Further, the hand-writing of Mr. Anthony Jeyaraj of the school is available. The proposal was processed hurriedly and secretly without the knowledge of others. No.6 of you has blindly approved the pension and gratuity in Pr.AG(A&E)/PEN P23/12318739/3/ R2318739 dated 29.08.2017 without verifying the conditional approval given to the appointment of the concerned teacher. Further, my representations dated 11.12.2017 and 17.03.2018 were not considered. All of you are fully aware that my case was pending as Civil Appeals No.1868-69 of 2014 and they were disposed in my favour on 12.03.2018 by the Hon'ble Supreme Court of India.

Even after receiving the copy of order passed by the Hon'ble Supreme Court of India dated 12.03.2018, you have not cancelled the illegal pension order granted to Mr.Jeyaseelan Anthony Raj in R.C.No.4103/B4/17 dated 04.08.2017 and no order has been passed to recover the money granted to the school on the basis of conditional approval given to the above teacher. All of you have been putting heavy financial burden on the government by negligence of duty and by non-compliance of Hon'ble Court orders.


Hence, under these circumstances, I call upon No.1 of you to cancel the conditional approval given in proceedings Na.Ka.No.10326/B3/98 dated 18.12.98 and pension order granted to Mr. Jeyaseelan Anthony Raj in R.C.No.4103/B4/17 dated 04.08.2017 with immediate effect and pass appropriate orders to the school management to remit back all the grants received from 24.08.1998 to date for Mr.Jeyaseelan Anthony Raj in the treasury with immediate effect on the basis of the above conditional approval.

I hereby call upon No.6 of you to cancel the order Pr.AG(A&E)/PEN P23/12318739/3/R2318739 dated 29.08.2017 through which pension and gratuity have been sanctioned to Mr.Jeyaseelan Anthony Raj. (Please vide my representations dated 04.09.2017, 27.09.2017, 11.12.2017 and 17.03.2017).

I hereby call upon No.2 and No.5 of you to take immediate action for cancelling the Conditional Approval given in proceedings Na.Ka.No.10326/B3/98 dated 18.12.98 and Retirement Benefits sanctioned in R.C.No.4103/B4/17 dated 04.08.2017 and all other attendant benefits given to Mr.Jeyaseelan Anthony Raj with immediate effect. Please be informed that you have caused a heavy loss to the government by issuing wrong orders and by getting huge grants from government by suppressing facts.

If appropriate action is not taken immediately, I regret to state that, I will be forced to initiate Contempt Proceedings against all of you for not complying with the Hon'ble Madras High Court order passed in WMP.No.22211/98 on 22.09.1998. In addition to the contempt proceedings, appropriate action will be taken against you all for misusing power and public money.
